The following table sets out our current retreat prices, together with the corresponding levels of the 20% deposit that is the minimum payment required to secure your registration on the retreat of your choice.

To take advantage of Early Bird prices, you must pay the total fee for the retreat no later than six weeks before the retreat begins (or a later date that we might publish).

If you are paying a deposit only in the first instance, and you intend to take advantage of the Early Bird price, it's OK with us that you pay a deposit of 20% of the Early Bird price only. But remember that your final payment must be made before the Early Bird cut off date, or the higher Standard price will apply.

Please note: If you live close to the retreat venue and you can easily travel between home and the venue, or prefer to use alternative off-site accommodation close to the venue, we can offer a reduced rate. This arrangement may suit people who wish to incorporate one of our retreats into a longer visit to the region.

To pay by **cheque**, send your registration form and a cheque made out to Pacifis Pty Ltd to the above postal address.

When we accept your registration, we will send you a written confirmation. If we cannot accommodate you on the particular retreat you have requested, we will contact you, and ask you what you want to do.

Tax invoices will be provided with our confirmation letter. If you have only paid a deposit, then we will inform you of the total amount remaining to be paid, and any Early Bird cut off dates that may apply.

Closer to the date of the retreat, we will send you further information about the retreat, together with a further tax invoice/statement for any further fees paid or outstanding.

CANCELLATIONS AND REFUNDS POLICY

What will happen if we cancel a retreat?

If we cancel a retreat, we will contact you immediately, and offer to place you on a similar retreat of similar value that will be held on a later date.

You will not be charged any higher fee for a similar retreat that we offer you.

We may also offer and you may accept placement on a later retreat of lower value, and in this case we will refund the difference between the fee you have already paid and the fee that you would have paid for the lower value retreat.

We may also offer and you may accept placement on a retreat of higher value, and in this case the upgrade to the higher value retreat will cost you no more than the difference between the fee you have already paid and the Early Bird price currently prevailing for the higher value retreat.

In the event that there is no agreement reached between us that results in you being placed on a later retreat, then we will refund the full amount of any fee already paid to us.

What happens if you withdraw from a retreat?

You are welcome to transfer any deposit and/or other fees already paid to a later retreat of the same or greater value.

GIFT CERTIFICATES/DISCOUNT VOUCHERS

The following special terms and conditions apply to the use of "Sense the Tango" Gift Certificates and Discount Vouchers.

The recipient of a Certificate/Voucher may use the Certificate/Voucher to reduce the total price of any residential tango retreat by an amount equal to the value of the Certificate/Voucher.

A Certificate/Voucher is valid for two years from the date of issue recorded on the face of the Certificate/Voucher, or any earlier expiry date recorded on the face of the Certificate/Voucher, and expires after that time. The recipient of the Certificate/Voucher must register and pay for a "Sense the Tango" residential retreat within this timeframe (even if the retreat the recipient has chosen to attend will occur after the date of expiry of the Certificate/Voucher). In some cases, other explicit conditions of use will further limit the use of a Certificate/Voucher.

The Certificate/Voucher must be attached to the registration form at the time the recipient registers for a retreat. A Certificate/Voucher recipient registering for a retreat should retain a copy of the Certificate/Voucher for their records.

The recipient of a Certificate/Voucher cannot redeem the Certificate/Voucher as cash.

The original recipient of a Certificate/Voucher is free to transfer the Certificate/Voucher to a new recipient. If the Certificate/Voucher has been produced with a particular recipient's name on it, then the original recipient must advise Pacifis Pty Ltd in writing of the name of the new recipient, and the Certificate/Voucher number of the Certificate/Voucher being transferred. The date of issue of a Certificate/Voucher is not changed as a result of a transfer of ownership. All the terms and conditions that applied to the original recipient will apply to the new recipient.

Our standard policy regarding eligibility for Early Bird Prices (see page 1) and our Cancellations and Refunds Policy (above) applies to holders of Certificates/Vouchers.
